#### GEORGE MCNEES MEMORIAL SCHOLARSHIP

George F. McNees was born April 1, 1933, in Crawford County, Iowa, but grew up in Taylor County and graduated in 1951 from Gravity High School. He served his country in the Army from 1953-1955. George married Martha Leonard of Bedford in 1956, and was employed at the Union Pacific Mail Terminal in Council Bluffs for nine years. Upon its closing, he transferred to the Clarinda Post Office where he was a window clerk for 24 years. George then retired in 1989 and became a full-time farmer.

George and Martha have spent 50+ years in the Clarinda School District. Their two children attended Clarinda schools and graduated from Clarinda High School in 1979 and 1983 respectively.

George passed away on February 4, 2016. Beginning in 2017, the George McNees Memorial Scholarship Fund will be awarded to a graduating senior of Clarinda High School who is eligible for enrollment in an accredited college or university and majoring in agriculture or business. From 2017 thru 2024, the annual scholarship will be \$1,000, with the final award being granted for \$1,100 in 2025.

George always enjoyed helping people and the family feels this scholarship is a way for George to continue helping others, especially the younger generation as they further their education.

He is currently the Regional President for Bank Iowa Clarinda.



Throughout Gilbert's 30-plus year banking career, he has chosen to be involved in the community through memberships in numerous civic organizations, serving as a Board member of local chambers, development boards and school foundation boards. Gilbert states, "I've always been highly involved and active in the six Midwest communities I lived in since college. ## EVELYN HERZBERG EDUCATIONAL SCHOLARSHIP

Evelyn Sunderman Herzberg was born February 2, 1929, to Wilbert and Emma Bredehorst Sunderman. She was brought up

in a Christian home by loving parents on a farm in the Immanuel Lutheran Territory northwest of rural Clarinda. Evelyn graduated from Clarinda High School in 1947 and later took various college courses at Iowa Western pertaining to her work. Evelyn was married to the late Willis (Bill) Herzberg in 1954.

Evelyn worked as office secretary for four years at the Clarinda Chamber and remembers it fondly. In 1951, she joined Page County State Bank as a bookkeeper and secretary. Throughout her years with the bank, she worked in various positions until she retired as Assistant Vice-President in 1985.

Evelyn credits her work ethic to growing up as a farm girl where each family member was taught to do their job and do it well. Those who know Evelyn would describe her as a people person, as Evelyn truly enjoys interacting with people. In addition, Evelyn has opened her home to many A's players over a 20+ year span and has never regretted it. She also hosts regular attendees of the Glenn Miller Festival.

Evelyn established the **Evelyn Herzberg Educational Scholarship Fund** at the Clarinda
Foundation with the first \$1,000 scholarship to
be awarded in May 2017, and annually for at
least seven years.

When asked why she chose to do this, Evelyn stated, "It is my pleasure to give back to the

community I am so proud of. It was a blessing to attend the Immanuel Lutheran School from kindergarten through 8<sup>th</sup> grade. Then I took the big step moving on to the Clarinda High School where I was accepted so graciously. The growing up memories will last forever.

Since I am a graduate of the Clarinda High School, it seemed only fitting to give back. College prices seem to have skyrocketed and any little boost I can give to a student wanting to further their education seems like the proper thing to do. There is a demand for young people to go to a trade school as we need carpenters, plumbers, mechanics, etc. Those who prefer a university where they can choose so many various occupations is also very important. With what little extra funds I have to share, it makes me feel so good that I can repay my hometown folks in a small way. The work ethic that was instilled in me since I was small and has stayed with me to an older age is such a blessing, hence giving back comes only natural. May this scholarship be a blessing to an appreciative student."

## CLARINDA VETERANS SCHOLARSHIP

A local group of Veterans has hosted a golf tournament for the past five years. A portion of the proceeds from that event has gone to establish the **Clarinda Veterans Scholarship** through the Clarinda Foundation. The scholarship will provide tuition aid for post-secondary education of a Clarinda or South Page graduate planning to enroll at an accredited technical/vocational school or college. The graduate must be a descendent (child, grandchild or great-grandchild) of a U.S. Veteran. Special consideration will be given to need, scholarly achievement, character, and reputation. Three \$1,000 scholarships will be awarded in 2017.

On May 10, 2016, Clarinda Foundation Board Director Scott Brown and Executive Director Pam Herzberg had the honor of presenting the 2016 Scholarship Awards at the Clarinda High School Awards Program. This year, the **Foundation awarded \$43,800 in scholarships**, which reflects an overall total of about \$380,000 awarded through scholarships since 1987.

### 2016 GRANT AWARDS

On August 9, the Clarinda Foundation hosted a special event at the Clarinda Lied Public Library—community organizations receiving 2016 Foundation grants were recognized, while at the same time the Foundation's "30<sup>th</sup> Anniversary" was celebrated. Along with a brief overview of the Foundation's 30-year tenure and recognition of outgoing board members, grant recipients were recognized and three recipients gave short presentations. Light refreshments and fellowship followed with Board members, grant recipients and the public.



As stated by Executive Director Pam Herzberg, "The Clarinda Foundation has been a driving force and lead fundraiser for multi-million dollar projects such as the Lied Center and the Lied Public Library. This year, the Foundation Board awarded \$76,044.84 in grants, taking the total awarded since 1986 to nearly \$839,000. In addition, the Foundation has awarded approximately \$380,000 in scholarships since 1991. None of the grants and scholarships would have been possible without the thoughtfulness of individuals who wanted to make present and future provisions for our community."

# Celebrating 30 Years of Service to Our Community: Executive Director Pam Herzberg Walks Down Memory Lane

In 1985, an effort to establish a community foundation was revived. On September 29, 1986, the **Clarinda Foundation, Inc.**, became a State of Iowa certified corporation, classified as a 501(c)(3) non-profit by the IRS, meaning all contributions are tax deductible to the extent of the law.

- Incorporators and members of the original Board of Directors included: Michael Thompson, Lowell Lines, J. P. Montgomery, Ken Cassat and John Lisle.
- At a special meeting on November 13, 1986, 10 additional individuals were selected to serve on the inaugural Clarinda Foundation Board. They were: James Millhone, Bill Richardson, John Clark, Bob Bailey, Marie Sump, Evelyn Herzberg, Kenneth Jensen, Lowell Geer, Clarence Lippert, and Mernie Hays.
- There have been four executive directors during the past 30 years: Janice Layton, Robert Caswell, John Woolson, and myself.

Throughout its history, the Foundation has provided individuals passionate about our community an avenue to invest in its future betterment. Many people have made their livelihoods and enjoyed the quality of life they have been afforded in this community. They see being contributors to the Foundation and supporting its work as a way to pay it forward.

In February 1987, Robert & Karen Duncan, former residents of Clarinda, issued a challenge to the Clarinda Foundation with the \$25,000 contribution they made to assist in establishing the Foundation. The gift from the Duncans would go to the Foundation's "unrestricted fund," but it was contingent upon the Foundation's receipt of gifts and pledges totaling at least \$50,000 within one year. We met the challenge—the Clarinda Foundation has now accrued approximately \$4 million in assets.

In 1990, the Clarinda Foundation brought community needs to the forefront by exploring the possibility of a community center. In late summer 1991, the **Lied Foundation (administered by former Clarindan, Christina Hixson)** made a \$500,000 challenge toward construction of a Clarinda Community building. The grant was contingent upon matching funds of \$500,000 being raised by the community, and coordinated by the Foundation. Past and present community members and organizations collaborated in fundraising efforts to meet that challenge. Then in December of that year, Hixson increased her original \$500,000 challenge grant to \$750,000. The groundbreaking ceremony was held on September 1, 1992, with the Lied Center opening for public use on April 18, 1994, in Clarinda's City Park.

#### And so it goes in our history ...

- No sooner had the Lied Center project concluded when the Foundation started accepting donations for a new track project for the school district.
- Two special Clarinda Foundation funds were established in 1987 to support community needs. These two funds were initially called "The Book of Memory" and "The Book of Honor," but they have since been merged into one, "The Book of Honor." Since its inception, about 2,000 individuals have been honored and are now listed in "The Book of Honor."
- Many individuals have chosen to participate in the Foundation's "Share with Clarinda" Program contributing \$100 per year to the Foundation. A percentage of these funds are distributed annually into the community through our grant process.

They recently visited Clarinda and other parts of the Midwest to connect with family and long-time friends. Their visit included a stop into the Clarinda Foundation, which they have supported financially over the years, to pick up the latest Christmas ornament. A chat with Pam Herzberg about current activities funded by the foundation, and the Fallers' desire to stay connected to their Clarinda roots resulted in a new volunteer opportunity. They have begun partnering with Foundation leadership to publish our Foundation newsletter.

The Fallers were married in Clarinda in September, 1976, and began their life together in Kansas City. In 1981, careers, educational opportunities, and adventurous spirits led Bob and Sheryl to relocate to the northwest.
